

#### Notes from Town Hall Meeting March 2, 2025

Deacon Dave Mareske opened the meeting at 11:55 am with prayer and a story about "finding the right fit".

Diane Bottorff gave an update, referencing the notes from February Town Hall meeting. The notes from February were sent out by email. If you didn't receive them, request a copy from church office. She noted a recurring theme that we are a family and we know our fellow worshippers. Another theme was the need for leadership. She gave a summary of Task Force (Bob Kobbeman, Bob Horton, Carol Marker) activity to date. Task Force has been set up to make contact with potential non-profit groups or congregations that may have an interest in sharing space in our building. There was a meeting in January with the pastor of Remnant Church. Bob Kobbeman, Curt Lewis, and Diane participated in that meeting. Remnant has requested another meeting to be set up toward the end of March.

Bob K has been in contact with Kansas Commercial Real Estate, but no contact has been initiated with Narthex Properties. Curt Lewis urged the Task Force to make contact with Narthex.

During Lent we are partnering with Our Saviors Lutheran for Ash Wednesday, Lenten midweek soup suppers and worship and also Maundy Thursday and Good Friday worship.

There are opportunities for us to be involved in providing food items for the soup suppers and taking parts during the worship services. Contact Diane or the church office if you'd like to volunteer.

Dean McGinnis shared the purpose of today's meeting. It included more discussion, more reflection and to learn about volunteer opportunities both at Trinity and beyond Trinity. An agenda for the meeting was distributed as well as an updated Time and Talent form and a handout showing the committee structure (Administration, Congregational Life, Community Relations, Maintenance, Spiritual Care). Dean asked each person to complete a Time and Talent form to indicate their ability and availability to serve/support Trinity during this time of transition as we move forward Page 2 of the agenda was a series of four reflection questions. Each table was asked to take time to reflect on the questions and share their thoughts with those at their table. Following this each table was given an opportunity to share with the group.

One of the questions asked participants their preference for primary worship times(s) and day(s) they would be willing to attend. Answers were: earlier times may be difficult for some, Saturday evening, Sunday afternoon, If sharing space we may need to be flexible, Sunday **is** church, 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup> Sunday Trinity and 2<sup>nd</sup>, 4<sup>th</sup> other churches; traditional worship but flexible time.

Another question was about the leadership role and what we expect the role of leaders to be, Duane Pomeroy responded to this by saying a council member chairing or co-chairing a committee solidifies leadership. Curt Lewis asked about the difference between leader, liaison and chair of committees. Dean commented that the sub-committees of Congregational Life committee are made up of the persons most suited to the task with talents and skills. Dean commented that without a pastor the leader of the congregation is the council. Diane said she heard the word complacency used in the sermon today. She cautioned members to avoid being complacent about our situation at Trinity.

On-going discussion continued. Curt shared that treasurer Bob Kobbeman is concerned about the decision making holdup-"no decision is a decision". If we are going to share our space with another entity, details need to be worked out.

Marcy Carlson stated that we have to do something. Money is an issue. If we do nothing, Trinity is likely to close in two years or less. How do we do what needs to be done? What are ramifications of each decision? Renting to another entity will increase need for security.

How do we walk in the way of Christ?

Debbie Pomeroy said that we must look at reality. Town Hall meetings have made us realize we cannot sustain. Alternative partnerships follow through, "finding the right fit". Task Force begin discussions and make recommendations to council. Might Town Hall meeting make a recommendation to council that the Task Force be authorized to move forward investigating possible partnership(s)?

Parker Jackson sees the goal as seeking multiple offers from potential partners. Any member or friend of Trinity might seek out offers. If we know of a possible partnership opportunity, pass that information to a member of the Task Force or to the church office.

Parker made a motion to direct the Task Force to move forward with investigating opportunities for sharing our building with other entities, i.e. congregations or non-profit organizations. Any negotiations made by the Task Force will be forwarded to the congregation council. If approved by council, it will be recommended to the congregation at a congregational meeting. Debbe seconded the motion. Motion was approved by those present.

Two members expressed concern about the beliefs of a congregation we might share our building with. Marcy mentioned we should consider what they believe compared to what we believe. Shelley Andrews said that we need to be careful about what a certain partnership may signal to others. Curt remarked that it would be a business partnership only.

Marcy asked what we can do to attract new members and how we can put effort into revitalizing the congregation in addition to seeking partnerships. Debbie urged that we continue bringing in new members and perhaps do some fund raising.

As the meeting was coming to a close, Dave Mareske spoke about Hollis. They are beginning a fundraising campaign. He shared brochures about their plans for expansion, and suggested we might consider coming to Hollis for a retreat. He urged us to look for someone outside of Trinity to lead the retreat and to focus on our mission versus survival.

There will be no Town Hall in April but updates will be given during announcements at worship the first Sunday in April and in the Tidings.
